Prior to GE, Marquis was with Donahue Schriber, a private REIT specializing in retail shopping centers, where he underwrote new acquisitions and created budgets for their \$2 billion portfolio. He also spent five years at Sperry Van Ness, a commercial brokerage firm, where he worked with the top retail team and closed over \$350 million in transactions.

Marquis holds a MBA from the University of California, Irvine, and is a graduate of Brigham Young University in Provo, UT. He will work closely with the Asset Management Team and will oversee Investor Relations from Pacifica Hotels' Santa Barbara office.
